## 56. BOLSOVER LOCAL AREA CO-ORDINATION – Marie Billyeald

Marie Billyeald (Service Manager for Prevention for D.C.C.) gave an overview of an initiative to build resilience into local communities and reduce the need and demand for formal services.

A co-ordinator's post is being created and will be based in Creswell with the aim of supporting people with disabilities, those with mental health needs, older people and their families/carers. Interviews will take place in November to appoint to the new position.

### 57. SPORTS DEVELOPMENT IN CRESWELL - Lee Hickin

Lee Hickin (Assistant Director of Leisure Services BDC) attended the meeting to outline how he would like to use Creswell as part of a pilot scheme to encourage and increase participation in sport. Mr Hickin asked if the Parish Council would support this initiative and would return to a future meeting with more detailed proposals including suggestions into how the Parish Councils sports coach could be involved. Following discussion the Parish Council agreed that they were fully supportive of Mr Hickin's aims and objective.
